

za Zračnu luku Zagreb 2005. godina predstavljala je godinu u kojoj su svi pokazatelji, kako naturalni, tako i finansijski bilježili značajan rast. Ostvarena je dobit iz poslovanja od 15 milijuna kuna, a poboljšanje poslovnih rezultata u odnosu na prethodnu godinu je vidljivo naročito kroz porast poslovnih prihoda za približno 10%.

Promet raste u svim segmentima, što se iskazuje kroz povećanje broja slijetanja za cca 17%, te tonaže zrakoplova od cca 15,5%, dok je broj putnika povećan za preko 10%, a prijevoz tereta za značajnih 40% u odnosu na ostvareno u prethodnoj godini.

Ukratko se može reći da je poslovanje Zračne luke Zagreb stabilno i da su stvorene dobre pretpostavke za novi investicijski ciklus, u kojem će središnje mjesto zauzimati gradnja novog putničkog terminala, koji ima veliki značaj kako za Zračnu luku Zagreb, tako i za grad Zagreb i cijelu Hrvatsku. Do izgradnje novog aerodromskog kompleksa, moramo nastojati funkcionirati u postojećim kapacitetima, kako bi naši putnici, zrakoplovne kompanije i svi korisnici naših usluga bili zadovoljni našim uslugama u pogledu kvalitete i efikasnosti. Osiguranje sigurnosti i redovitosti zračnog prometa je kontinuirani zadatak, te se u tu svrhu nabavlja nova modernija i sofistirana oprema i obavlja sanacija potoječih kapaciteta (npr. odleđivač manevarskih površina, Follow-me vozila, obavljena je sanacija asfaltnog kolnika, postavljena ograda, izvedena sanacija krova u putničkoj zgradi).

Podizanje kvalitete usluga je naš svakodnevni zadatak, te se u tu svrhu razmatraju svi zahtjevi naših poslovnih partnera, kako kompanija, tako i putnika. U tom se smislu obavlja kontinuirano stručno istraživanje zadovoljstva putnika i kompanija, uvažavaju se sve sugestije i primjedbe, te se poduzimaju, u skladu s mogućnostima, maksimalni napor da kvaliteta naših usluga ne dođe ni u jednom trenutku u pitanje.

Integrirani sustav kvalitete i upravljanja okolišem neprekidno se nadograđuje i usavršava, što se manifestira kroz unapređenje kvalitete i zadovoljstvo korisnika naših usluga. U svrhu daljnog poboljšanja efikasnosti procesa u društvu, uvodi se Sustav 20 ključeva, kao i Sustav mjerjenja efikasnosti intelektualnog kapitala.

Dear Sir or Madam,

for Zagreb Airport 2005 was the year in which all physical indicators and financial ratios reported significant growth. Profit of 15 million HRK was made, and the improvement of business results is particularly evident in the rise of revenues by approximately 10% in comparison with the previous year.

Business has flourished in all segments, which is evident from increase in the number of landings by approx. 17%, increase in maximum take-off weight by approx. 15.5%, increase in the number of passengers by approx. 10%, and increase in cargo transport by considerable 40%, compared to the previous year.

To sum up, we may say that Zagreb Airport conducts a steady business which has created conditions for the new investment cycle, the focal point of which is to be the construction of New Passenger Terminal, of great importance not only to Zagreb Airport, but also to the city of Zagreb and the whole of Croatia. Until the new airport complex is constructed we have to make efforts to function within the existing capacities and secure the quality and efficiency of our services that will satisfy the needs of our passengers, air companies and all service users. Obtaining safety and regularity of air traffic is our permanent task, and for that purpose we tend to supply some new, modern, and more sophisticated equipment, as well as reconstruct the existing facilities (e.g. maneuvering area defroster, Follow-me cars, the asphalt road and the roof of the passenger terminal were reconstructed, the fence was built).

Increasing the quality of our services is our everyday mission, and for that purpose we give consideration to all requests by our business partners, both air companies and passengers. In this respect we continually conduct surveys on the level of satisfaction of our passengers and air companies, acknowledge every suggestion and remark, and make maximum efforts, according to our possibilities, not to call into question the quality of our services.

The Integrated System of Quality and Environment Management is continually expanded and improved, which is manifested in quality improvements and satisfaction of service users. For the purpose of further efficiency improvement of the process in society, we are about to introduce Twenty Keys System and Intellectual Capital Efficiency Measurement System.



Društvo je dana 8. veljače 1996. godine u sudskom registru Trgovačkog suda u Zagrebu, rješenjem broj Tr-95/12085-2 upisalo uskladenje općih akata i temeljnog kapitala sa Zakonom o trgovackim društvima. U tijeku 1997. godine Zračna luka Zagreb, d.o.o., osnovala je Zračnu luku Zagreb - Trgovinu, d.o.o. i Zračnu luku Zagreb - Ugostiteljstvo, d.o.o. koje su u stopostotnom vlasništvu Zračne luke Zagreb, d.o.o. Članovi društva su 19. svibnja 1988. godine zaključili društveni ugovor kojim se utvrđuje da je Zračna luka Zagreb, d.o.o. čiji je član Grad Zagreb, sukladno Zakonu o zračnim lukama, postala društvo s ograničenom odgovornošću, čiji je član Republika Hrvatska, Zagrebačka županija, Grad Zagreb i Grad Velika Gorica. Članovi društva u temeljnem kapitalu sudjeluju s temeljnim ulozima na način propisan Zakonom o zračnim lukama.



On February 8, 1996 by Decision Tt-95/12085-2 the Company entered the harmonization of general acts and stock capital with the Trade Associations Law into the Commercial Court register.

During 1997 the Zagreb Airport Ltd. established

Zagreb Airport - Trading Ltd. and Zagreb Airport - Catering Ltd, which are fully owned by Zagreb Airport Ltd. Members of the Company concluded a contract on May 19, 1998; by this contact, Zagreb Airport Ltd., with the City of Zagreb as its member, has become, in compliance with Airports' Law, a company with limited responsibility, having as its members the Republic of Croatia, Zagreb County, the City of Zagreb and the Town of Velika Gorica. The company members participate in the share capital with their equity in compliance to provisions of the Airports' Law.



Predmet revizije

Independent Auditor's Opinion on Financial Statement

Subject of Auditing

We carried out auditing of financial reports of the company ZRAČNA LUKA ZAGREB d.o.o. Zagreb, Pleso bb (the Company), presented on pages 3 to 6, for the business year ending on 31 December, 2005.

Responsibility of Management Board and Auditors

We believe that the stated level of auditing tests is sufficient to express the opinion on the financial reports.



Finansijski izvještaji pripremljeni su na temelju pretpostavke neograničenosti vremena poslovanja i izrađeni su u kunama.





Promet zrakoplova u 2005. godini u odnosu na prethodnu povećao se za 16,8%. Tonaža zrakoplova je veća u 2005. godini u odnosu na prethodnu za 15,5%. Promet tereta i pošte je veći za 2005. godinu u odnosu na prethodnu za 40,4%. Promet putnika je u 2004. godini porastao za 7,1%, pri čemu je u redovnom prometu zabilježen porast od 6,8%, a u izvanrednom prometu 13,1%.

In the year of 2004, the airplane traffic increased by 9.4% in relation to the previous year. In 2004, airplane tonnage is grater by 12.5% when compared to the previous year. Domestic and international airplane tonnage shows growth when compared to the previous year. Airplane tonnage in charter traffic has been increased by 23.6%. In 2004, the passenger traffic increased by 7.1%, whereby the increase of 6,8% was reported in scheduled traffic, while in the charter traffic it amounted to 13.1%.


